SUPPORTING THE UNIQUE NEEDS OF PRE AND POST ADOPTIVE FAMILIES

NAC's Adoption and Kinship Support
Program offers children and families
being formed through adoption or
guardianship, a place where they can find
the support, advocacy, information, and a
range of professional health and social
services needed to help them create or
maintain a successful and permanent
home.

Each program, Post Adoption Legal
Network, Post Permanency Support
Program, and Family Permanency
Center are designed to meet the needs of
children in various stages of the
adoptment process.





Post Legal Adoption Network

 Children must be freed for adoption to receive services.

Post Permanency Support Program

- Children and families who are within 90-days of exiting the NYC foster care system via adoption or kinship guardianship.
- Children who have already been adopted or exited foster care to kinship guardianship via the NYC foster care system and their families.

Family Permanency Center

- Adoptive Families who have finalized the adoption of their child. This includes private placement adoptions and international adoptions.
- Guardianship Families including Kinship caregivers who have legal guardianship of the child and an approved KinGAP agreement or families with legal guardianship without a KinGAP agreement.

FAMILIES WILL:

Receive invaluable support services and advocacy to strengthen the entire family and enable children to reach for and realize their potential.

Learn about adoption and guardianship family resources and how to advocate for yourself and your child.

Connect with other families to share parenting concerns and challenges; and receive encouragement and support.
